The papers of William D. Leahy, naval officer, diplomat, and governor of Puerto Rico, were given to the Library of Congress by Leahy in 1955 and 1959. Additional papers were given by his son, William H. Leahy, in 1971.

The papers of William D. Leahy were arranged and described in 1972 and 1975. Part of the collection was reprocessed for filming in 1985, and the finding aid was revised in 2006.

## Scope and Content Note

The papers of William Daniel Leahy (1875-1959) span the years 1897-1959, with the bulk of the items concentrated in the period 1935-1959. Included are diaries and related matter; correspondence, notes, and writings associated with the publication of Leahy's World War II memoir, *I Was There*, which was an amended version of his diaries for the period; and scrapbooks and miscellany. The papers are organized into the following series: [Diaries](#), [Special File](#), [Writings](#), [Scrapbooks](#), and [Oversize](#).

Important in the papers are the [diaries](#) Leahy kept for the years 1893-1956. Begun formally in 1926, they consist of typed transcripts of notes and recollections from when Leahy was a graduate of the United States Naval Academy through when he was an ambassador, chief of staff, and adviser to presidents Franklin D. Roosevelt and Harry S. Truman. The first volumes are significant for their portrayal of Leahy's early naval experiences as well as for their depiction of the increase in his diplomatic and strategic responsibilities. As a young officer, Leahy saw duty in various international hostilities. Limned in the diaries are his experiences aboard the *Oregon*, on which he sailed around Cape Horn to the Caribbean in time to encounter the Spanish fleet off Santiago, Cuba, in 1898; his assignment shortly thereafter to Asia, where he saw action first in the Boxer Rebellion and then in the war against Filipino insurrectionists; and his presence in the civil war in Nicaragua in 1912, where he was part of intervening American forces. Also described are his roles in World War I and his multifaceted duties as administrator and spokesman within the navy bureaucracy.

In 1939 Leahy retired from the service to become governor of Puerto Rico. Two years later he became ambassador to France. The diaries treat both episodes, with the richest segment containing accounts and documents of Leahy's mission regarding Vichy collaboration with Adolf Hitler and the Allied attempt to prevent the transfer of the French fleet into German hands. After 1942 the diaries take on a more global perspective, covering important diplomatic and strategic aspects of the Allied war effort. As chief of staff to the president and chairman of the Joint Chiefs of Staff, Leahy observed events from the highest political and military echelons. He was a participant at the Big Four Conferences in which the shape of postwar international relations was sketched -- Cairo, Teheran, Yalta, and Potsdam -- and his diaries depict the evolution

of American foreign policy decisions after World War II, including the curtailment of lend-lease aid to Russia, deteriorating East-West relations in Central and Eastern Europe, and the problems of military aid to Nationalist China.

Correspondence in the Leahy Papers is limited to official letters tipped into the diaries and to a small file concerning publication of *I Was There*. Prominent among the correspondents in the diaries are Bernard M. Baruch, François Darlan, Joseph C. Grew, Cordell Hull, George C. Marshall, H. Freeman Matthews, Philippe Pétain, Eleanor Roosevelt and Franklin D. Roosevelt, Harry S. Truman, and Sumner Welles. Valuable as well are other items tipped into the diaries, including photographs, naval and State Department documents, indexes of Leahy's early ship assignments, and a few hand-drawn maps.

The scrapbook series, which dates from 1935 and amplifies the diaries as a chronological record of Leah's activities, contains photographs and ephemera in addition to clippings. Material relating to *I Was There* is noteworthy for offering a comparison of the published version of Leahy's memoirs against his earlier recollections and for containing a signed copy of the foreword by President Truman.
