Art. 8. No River or Boundary of Prussia, his majesty the king of Prussia, nor the city of Danzig, shall oppose any obstacles whatever to the free navigation of the Vistula under the terms of this article or during its establishment. It is in order as far as possible to establish a natural boundary between Prussia and the duchy of Warsaw, the territory between the present confines of Russia from the King to the river of the Niemen shall continue as a line from the mouth of the Lwowa along the top of all the hills which divide the territory of the Bishopric to its mouth; that of the Niemen, from the mouth of that river as far as Szumlau; from Szumlau to a ravine near the village of Mem; from this ravine to Nitzkau; and from Nitzkau to the mouth of that river beyond Nitz; and finally along the winding path of the Bag towards the sea, for as the present frontiers of Russia, this territory is forever united to the empire of Russia.

Art. 9. No person of any rank or quality whatever, whose residence or property is within the limits of the territory in the above mentioned article, nor any inhabitant in those provinces of the Kingdom of Prussia, shall be given up by his majesty the king of Prussia, or any person possessing estates, revenues, pensions, salaries, or other political or military, which he may have taken in the event of the present war.

Art. 11. All contracts and engagements between his majesty the king of Prussia and the said provinces, relative to the general impost, the ecclesiastical military or civil service, the creditors or guarantors of the said Prussian government are to be settled between the emperor and his majesty the king of Prussia; and to be regulated by their sanction in proportion to the respective interests.

Art. 12. The Prussian rights and possessions in the Duchies of Oldenburg and Mecklenburg shall remain to the Emperor, and all rights which the said Duchies possess shall be settled by the Emperor and his majesty the king of Prussia.

Art. 13. His Majesty the Emperor Napoleon accepts of the mediation of His Majesty the King of Prussia to negotiate and conclude a Definitive Treaty of Peace between France and Prussia, however, only upon condition that this mediation shall be accepted by Britain in one month after the exchange of the ratification of the present Treaty.

Art. 14. His Majesty the Emperor of all the Russias has declared on his part to maintain his friendly and intimate relations with the two Empires, acknowledging his majesty Joseph Napoleon, King of Naples, and King of Holland, as Louis Napoleon, King of Holland.

Art. 15. His Majesty the Emperor Napoleon, in consideration of the present state of the possession of the Principality of Lippe, and of the treaties which were concluded upon them by the act of Confederation, and of the subsequent treaties of Commerce, His said Majesty promises: information being communicated to him on the part of the Emperor Napoleon, to acknowledge those sovereigns who may hereafter become members of the Confederation, according to their rank specified in the Act of Confederation.

Art. 16. His Majesty the Emperor of all the Russias consents that all his property in the right of sovereignty to the Kingdom of Naples be returned to his majesty the King of Naples.

Art. 17. The present treaty is concluded in the name of his majesty the King of Naples, Joseph Napoleon, his majesty the King of Holland, and the two sovereigns of the Confederation of the Rhine, in conformity with the Convention of the 12th of November 1806.

Art. 18. His Majesty the Emperor of all the Russias also acknowledges his Imperial Highness Alexander, Emperor of all the Russias, as King of Westphalia.

Art. 19. The Kingdom of Westphalia, in conformity with the Convention of the King of Prussia on the left bank of the Rhine, and other states at present in possession of his Majesty the Emperor Napoleon.

Art. 20. His Majesty the Emperor of all the Russias engages to recognize the limits which shall be determined by the Emperor of all the Russias in pursuance of the foregoing 19th article, and the contents of his Majesty the King of Prussia (which shall be inserted in his Majesty the Emperor of all the Russias), together with the state of possession resulting therefrom, to the two Sovereigns for whose behalf they shall have been established.

Art. 21. His Majesty the Emperor of all the Russias consents that he will be withdrawn from the province of Moldavia, but the said provinces may not be evacuated until the troops of the Grand Signor, till after the exchange of the ratifications of the above mentioned treaty, have been evacuated to the Ottoman Porte.

Art. 22. His Majesty the Emperor of all the Russias accepts the mediation of his majesty the emperor of France in order to settle the claims and claims relating to the two powers, and of concluding a peace between Russia and the Ottoman Porte.

The respective Plenipotentiaries shall repair to that place which will be agreed upon by the two powers, to meet there to open the negotiations, and to proceed therewith.

Art. 23. His Majesty the Emperor of the French, King of Italy, and his Majesty the Emperor of all the Russias mutually engage to each other the integrity of their respective territories, and to be satisfied in this respect of the state in which they are respectively situated, and to be satisfied pursuant to the above stipulations.

Art. 24. The present treaty shall be ratified by the Emperor of all the Russias, and the ratification shall be exchanged in the city of Vienna, on the 25th of July 1813.

Whitcall, July 23.

My Lord, I have the honor to transmit to you the copy of a notice given by the Commissioners of the Customs to the merchants concerning the vessels of the United States of America, and to the masters of all American vessels informing them that according to a determination of the Lords of his Majesty's most honorable Privy Council, ships sailing under the American flag, but not of the built of America or deemed as prize within the U.
